The Colorado Horse Park is pleased to offer our fourth annual Eventing Derby on May 1st. An eventing derby consists of a dressage test and a modified jumping course. The jumping course consists of both show jumps and cross-country fences set on varied terrain. There will be 10-18 jumping efforts that may include water, ditches, and banks as well as the standard portable jumps. The eventing derby will follow the USEA rules for combined tests as closely as possible. This will be an excellent opportunity for riders of all levels to try eventing and have a great time. Check our website for details that will be published soon. Information will also be available on the MSEA/USEA web site.

- 1) **CHP Eventing Derby Elementry**. Dressage: 2010 USEA Beginner Novice Test A. Jumping Course: Max. Height 2'-0", approximately 10-15 obstacles. Speed: 275 mpm.
- 2) **CHP Eventing Derby Beginner Novice I**. Dressage: 2010 USEA Beginner Novice Test A. Jumping Course: Max. Height 2'-7", approximately 10-15 obstacles. Speed: 300 mpm.
- 3) **CHP Eventing Derby Novice I**. Dressage: 2010 USEA Novice Test A. Jumping Course: Max. Height 2'-11", approximately 12-16 obstacles. Speed: 325 mpm.
- 4) **CHP Eventing Derby Training I**. Dressage: 2010 USEA Training Test A. Jumping Course: Max. Height 3'-3", approximately 12-18 obstacles. Speed: 350 mpm.
- 5) **CHP Eventing Derby Preliminary I**. Dressage: 2010 USEA Preliminary Test A. Jumping Course: Max. Height 3'-7", approximately 14-18 obstacles. Speed: 375 mpm.
